Introduction

This document, called "Code of Ethics" (hereinafter, also "Code") is an official document that expresses the commitments and ethical responsibilities in business conduct and company activities, assumed by the companies of Newster System S.r.l. (Hereinafter Company). Furthermore, it regulates the set of rights, duties and responsibilities that the Company expressly assumes towards those who interact in carrying out its business.

The Code must be considered an integral part of the employment contracts in place and to be stipulated.

The violation of its provisions will therefore constitute an offense of a disciplinary nature and, as such, will be prosecuted and sanctioned by the Company and may result in compensation for the damage caused to them.

With regard to the signing of this Code or the adherence to the provisions and principles contained therein by collaborators, consultants, self-employed workers and other third parties, who provide their activities in favor of the Company, it represents a condition for the stipulation of contracts of any nature between the Company and these subjects. The provisions thus signed or approved, even for conclusive facts, are an integral part of the contracts themselves.

Based on the foregoing, any violations by third parties of specific provisions of the Code may legitimize the Company's withdrawal from contractual relations with this parties. They can also be identified ex ante as causes for automatic termination of the contract.

Rules of conduct

The rules of conduct contained in this section are intended to indicate the conduct to be observed in carrying out the various company activities in accordance with the values which inspire this Code.

Collaborators

I Collaborators, understood as directors, employees and those who, regardless of the legal qualification of the relationship, operate under the direction or supervision of Newster System, must observe correct and transparent conduct in carrying out their duties.

Obligations of Collaborators

Each Collaborator is required to be aware of the provisions contained in the Code or referred to by it, as well as the relevant legal regulations that regulate the activity carried out within the scope of his / her function and which form an integral part of each person's work performance.

The Collaborator who has news of alleged illegal conduct is required to communicate the aforementioned information to the Sole Director of the Company and, where necessary, to their superiors. The Sole Director, with the support of superiors informed about the alleged illegal conduct, will notify the Supervisory Body in charge.

Collaborators also have the obligation to:

- a) refrain from conduct contrary to these provisions and rules;
- b) contact their superiors and / or Sole Director, for the necessary clarifications on the application methods of the Code or of the reference regulations;
- c) promptly report to their superiors and, where necessary, to the Sole Director of the Company any information regarding possible violations of the Code;
- d) collaborate with the Company in the event of any investigations aimed at verifying and possibly sanctioning possible violations.

Each company department manager is obliged to:

- c) make every effort to ensure that employees understand that the provisions contained in the Code are an integral part of their work performance;
- d) select employees and collaborators who undertake to respect the principles contained in the Code;
- e) promptly report to the Sole Director any reports or needs from their subordinates.

Each Collaborator who, acting in the name or on behalf of Newster System, comes into contact with third parties with whom the Company intends to undertake commercial relations or is obliged to have relations of an institutional, social, political or any nature whatsoever nature, has the obligation to:

- a) inform these subjects of the commitments and obligations imposed by the Code;
- b) demand compliance with the obligations of the Code in carrying out their activities;
- c) take the necessary internal initiatives in the event of a refusal by third parties to comply with the Code or in the event of failure or partial execution of the commitment undertaken in observing the provisions contained in the Code itself.

- Each collaborator is required to respect the principles of correctness, integrity, appropriateness and confidentiality in the use of IT applications: therefore all behaviors that may, in any way, even if only potentially, integrate violations of the provisions of internal procedures must be avoided adopted by the Company and by the applicable legislation.
- All Collaborators are required to avoid any activity or situation of personal interest that constitutes or could constitute, even if only potentially, a conflict between individual interests and those of Newster System.
- Each Collaborator is prohibited from taking part, directly or indirectly, for any reason whatsoever, in commercial initiatives that place themselves, even if only potentially, in a situation of competition with Newster System.

In the event that situations of conflict of interest, even potential, both internal and external to the company activity, are identified, each person involved is required to refrain from adopting the conflicting conduct, promptly notifying the Supervisory Body in charge, to the which is responsible for assessing the existence, case by case, of any incompatibilities or situations of prejudice.

Selection and hiring

Newster System recognizes the centrality of human resources in the belief that the main success factor of every company is the professional contribution of the people who work there, in a framework of loyalty and mutual trust. These principles are used to take the necessary measures to protect the safety and health of workers, including the prevention of occupational risks, information and training, as well as the preparation of an organization and the necessary means.

- company procedures must allow for carrying out controls on operations, authorization processes and their execution;
- every collaborator who carries out transactions involving sums of money, goods or other economically evaluable benefits belonging to Newster System, must reasonably provide the appropriate evidence to allow the verification of the aforementioned transactions.

Anti-money laundering

Newster System undertakes to prevent, by all means, the use of its economic instruments and its financial system for the purposes of money laundering, self-laundering or financing of any criminal activity of any kind.

- a) accurate accounting registration;
- b) the immediate identification of the characteristics and underlying reasons;
- c) easy formal and chronological reconstruction;
- d) the verification of the decision-making, authorization and implementation process, in terms of legitimacy, coherence and congruity, as well as the identification of the various levels of responsibility.

Recipients of this Code who become aware of cases of omission, falsification or neglect in accounting records or supporting documentation are required to promptly report them to the Manager / Sole Director and, where necessary, to their superior. The Sole Director informed of such cases will notify the Supervisory Body in charge.

Newster System promotes the launch of training and refresher programs in order to make the Recipients aware of this Code regarding the rules (laws or regulations, internal prescriptions, provisions of the trade associations) that govern training and management of accounting documentation.

Communication and training
